The Recreation Advisory Board meeting was held at North Middleton Township Complex, 2051 Spring Road, Carlisle, PA 17013 on April 28, 2015. Chairman David Hoover called the meeting to order at 6:30 p.m. Board members present were Chair David Hoover, Vice-Chair Jeff Brenizer, Secretary Lisa Darr, Laurie Hoover and Recreation Director Annette McKillip.

**Visitors:** None

Following the Pledge of Allegiance, the Minutes of the March 24, 2015 Recreation Advisory Board meeting were approved on motion of Jeff Brenizer, seconded by Lisa Darr. Motion carried unanimously.

**Directors Report:**

- A. **Pavilion Rentals:** Rentals on April 28<sup>th</sup> were eighty-one, totaling \$3,320 with 5,090 guests. There was no meeting in April 2014 to compare it to.

**Old Business:**

- A. **Background Checks:** Three different types of background checks were done on Lisa Darr (Easter Bunny & Elf) and Ken Snyder (Santa).
- B. **Benches:** The benches were ordered and were to arrive today.
- C. **Car Show:** Orrstown Bank will sponsor three hundred dollars for the price of the disc jockey. Karns will sponsor ten, ten dollar gift cards and one hundred coupons. An agreement was signed with Ray Thomas for the disc jockey. Brad's Pizza and Kwik Way will sponsor one hundred dollars each which will help cover the cost of the trophies and dash plaques. Horner's BBQ is willing to bring out a food truck to the event. Everyone would like to see more advertising of the car show to try to bring in more participants.
- D. **Disc Golf:** Last month we spoke about posting this on Facebook to gather feedback from the residents. After speaking with the manager, she informed that with the township's account, we do not allow for public comments or feedback. The Recreation Advisory Board has decided not to do anything with disc golf at this time. A letter will be sent to Mr. Hannan thanking him for his offer.
- E. **Easter Egg Hunt:** Thank you to everyone who helped out.
- F. **Event Staff T-Shirts:** The manager approved. It was decided to go to 2 Generations in Carlisle and talk to them about the type of shirts we had in mind.
- G. **Local Business Solicitation:** Tabled to next month.
- H. **Resolution:** The resolution revising and amending the amount of payment for contribution as required for recreation and open space was spoke of last month. A memo and new resolution were proposed to the Board of Supervisors.
